## 2019 Administrative Updates

- 1) FHSAA Policy 10.3.1—Minimum Contest Requirement. Student athletes must participate (compete) in six (6) contests in order to be eligible to participate in the Florida High School State Championship Series (District, Region, & State Finals).
- FHSAA Policy 6.1.2—School Contest Limitations. Golf teams are limited to a maximum of 16 regular-season contests and one (1) preseason contest.

\*Note--each of the following are considered a single golf contest:

- 9-hole match typically played after school irrespective of the number of teams participating (dual, tri, quad, etc.)
- 18-hole tournament or match
- Multiday events in excess of 18-holes
- 3) Classification and Assignments. Starting in 2019, each class will be comprised of 4 regions and 16 districts. Assignments are based solely upon school enrollment then geography.



## **2019 Administrative Updates Cont.**

- 4) State Series Advancement of Teams and Individuals.
  - District to Region. Top three lowest scoring teams and top three lowest scoring individuals not on advancing teams.
  - Region to State Finals. Top three lowest scoring teams and top three lowest scoring individuals not on advancing teams. Cont.
  - At-large Qualification to State Finals. Four additional teams and individuals not on those teams will advance to the State Finals based upon a rating established using score, slope, and course rating at the region tournament round across all regions.
- 5) Region Tournament Pairings. Pairings and tee times will be based on scores, course rating, and slope at the district tournament round.
- 6) State Finals Pairings. Parings and tee times will be based upon scores, course rating, and slope at the region tournament round.



## 2019 Administrative Updates Cont.

7) NEW—The FHSAA Golf App (iWanamaker)

<u>Team Management.</u> Member schools shall populate, update, and manage all player rosters throughout the season. This is available using the FHSAA Golf App.

- Head coach set up of their member school acount must be completed by the
   Friday prior to the start of Preseason Classics at 5:00 PM
- ♦ Roster setup on the FHSAA Golf App is due August 19, 2019 by 5:00 PM.

Regular Season Results Reporting. All regular season tournament and match hosts shall create each contest and report contest results utilizing the FHSAA Golf App (iWanamaker). Results shall be reported within 24hrs of the completion of each contest. FHSAA strongly recommends results be reported immediately following the close of competition.

#### Post-season Results Reporting and At-large Advancement.

- All post-season results shall be submitted and reported via the FHSAA Golf App (iWanamaker).
- ♦ At-large state qualification shall be determined using iWanamaker.

<u>Digital Scorecards</u>. The use of digital scorecards by players on their personal device is strongly recommended via the FHSAA Golf App (iWanamaker). Live scoring is strongly recommended for all events including post season.





## The FHSAA Golf App (iWanamaker)

New for 2019, FHSAA and iWanamaker have partnered together to advance high school golf in Florida. This partnership will enable member schools to manage their golf rosters, results, seeding, and more at no cost to schools. Additionally, iWanamaker will provide season team and individual rankings throughout the year. Schools also have an opportunity to fund their golf programs through the sale of tickets for access regular season and post season tournament results, rankings, and statistics via The FHSAA Golf App (iWanamaker).

Seeding at region and state finals and at-large advancement from the region round to the state finals will be based upon the ratings established at post-season competition. Each member school program is required to download the FHSAA App and manage their rosters, scores, and season on iWanamaker.
